Sub:- Andhra University - Affiliated colleges - students transfers/readmissions for the academic year -2019-2020- Regarding.

I am by direction to inform that transfers/readmissions of students in between affiliated colleges of this University and from other Universities in respect of I/II/III/IV/V years students for the academic year 2019-2020 are considered up to 15-06-2019 on the following grounds.

- 1. Transfer of candidates whose parents/guardians working in the Government/Public Institutions are considered and the transfer are permitted on production of transfer orders, relief orders and joining report. If there is no college on the place where the parent/guardian is transferred, the transfer would be considered to the nearby college.
- 2. Transfer of candidates whose parents/Guardians are retired from services and would like to settle down in a different place would be considered on production of retirement order within the two years period.
- 3. Transfer of candidates whose parents/guardians expired during the course of study would be considered to a place of their request on production of death certificate.
- 4. Transfer of Women candidates who got married during course of study and whose husband is residing in a different place would be considered on production of marriage certificate.

It is submitted that, while forwarding the applications of students for transfer, it is requested to ensure and follow the above conditions and also other conditions such as (i) No objection from the Principals of both the colleges (ii) Stating clearly the vacancy position in the admitting college etc., invariably and forward the applications of the students accordingly to the University for consideration.

The application proforma for the above purpose is enclosed herewith. Please see and enclose the following documents to the application scrupulously.

- 1. Marks Statements of the previous years of study.
- 2. Transfer Certificate in absence of no objection from the concerned Principal.
- 3. Attested copy of syllabus in the case of students seeking transfer from other Universities
- 4. Demand Draft in favour of the Registrar, Andhra University, payable at Visakhapatnam for the amount prescribed towards university fee .
