**Cancellation/Withdrawal**

These vacancy positions will be uploaded in official websites on 26-08-17.

**Eligibility for Phase – II Counselling**

Candidates who reported to the college where he/she allotted seat will not be eligible for Phase-II Counselling.

However the candidates who have not reported to the college where they are allotted seat on or before 24-08-2017 are eligible to attend Phase-II counselling.

The candidates who have given options but not allotted a seat (OR) not reported are eligible to give new options as per vacancy available.

**Registration and Certificate Verification**

All the NATA/ JEE AAT qualified candidates who have not attended to the registration cum certificate verification on 16<sup>th</sup> and 17<sup>th</sup> August 2017 are also eligible to Phase-II counselling only after completion of registration and certificate verification by paying processing fee of Rs.1200 for OC/BC and Rs.600 for SC/ST candidates. Registration and certificate verification will be done on 26<sup>th</sup> Aug 2017 from 10AM to 3PM and on 27<sup>th</sup> Aug 2017 from 10AM to 1PM at Department of Architecture, AU College of Engineering (A), Andhra University, Visakhapatnam.
