- 3) Analyzing data and providing evidence-based recommendations to BLOs, District level Officials to optimize developmental initiatives.
- 4) Organizing workshops, awareness campaigns, and skill-building programs to empower the local community.
- 5) Keeping States and NITI abreast with the issues, challenges and need for support.

Terms & Conditions:

- 1) You are hereby offered provisional deployment to the post of Aspirational Blocks Fellow in the Alluri Sitharama Raju District.
- 2) Your deployment to the post of Aspirational Blocks Fellow is provisional. ORDER:

The Aspirational Blocks Programme (ABP) was launched by the Hon'ble Prime Minister on 7th January, 2023, during the 2nd National conference of Chief Secretaries. This transformational programme focuses on improving governance to enhance the quality of life of citizens in the most difficult and underdeveloped blocks of India. In Andhra Pradesh state there are 15 blocks (mandals) were selected by NITI Aayog for Aspirational Blocks Programme, out of these 15 blocks (mandals), 3 Blocks (mandals) were selected from Alluri Sitharama Raju District namely Gangavaram, Y.Ramavaram and Maredumilli.

The programme division has proposed to deploying one fellow in each of the Aspirational Blocks for one year. The fellows deployed in the block office will assist the district & the block administration in implementation, and monitoring of activities under ABP and also in improving the quality of engagement of all stakeholders.


The districts will have to hire the fellows based on the terms of reference (ToR) by NITI Aayog. The PMU at NIRDPR and YASHADA will also support the fellows by organizing their induction to ABP and further capacity-building as per requirement.

In this context the District Collector, ASR District, Paderu has issued the press notification on Dt. 21.09.2023 as per reference 3rd cited above and conducted the selection process for the Aspirational Block Fellow (ABF) position from Dt. 30.09.2023 to Dt 17.10.2023



- 6) The District Collector, Alluri Sitharama Raju District/Project Officer : ITDA Rampachodavaram / MPDO of the concerned mandals will assign duties as per the job chart as per the Instructions of the NITI Aayog and report compliance.
- 7) The working days and timings are applicable as per government norms. The deployment is whole time and you should devote whole time attention.
- 8) You are hereby informed to report for duty before 31.10.2023 of receipt of the proceedings on failing which the offer of deployment may be treated as cancelled.
