DPIIT -IPR Chair, Centre for Intellectual Property Rights Andhra University invites applications from the Indian nationals only for the post of **JUNIOR RESEARCH FELLOW-JRF** (02 Positions) on contract basis under SPRIHA Scheme of DPIIT, Ministry of Commerce, Govt of India.

Interested candidates who are fulfilling the eligibility criteria may submit their biodata in a prescribed format as given in Annexure I in the detailed advisement given at Andhra University website www.andhrauniversity.edu.in. and may send it to email: iprchair.recruitment.au@gmail.com

The first closing date for receipt of applications is 7th January 2023. The shortlisted candidates would be interviewed through online/physical mode. The date of interview would be communicated to all the shortlisted candidates. The recruitment process shall continue till suitable candidates are found recruited. In case no suitable candidates are found the applications received up to 28.1.2023 would be considered (Second closing date).

Essential qualification: Master's Degree in Science Technology, Engineering or Management with Graduate Degree in Science or Engineering from any UGC recognized University.

Age: Below 35years as on the 7th Jan 2023.

Preference would be given for UGC-CSIR/NET-JRF qualified candidates and having experience in Intellectual Property Rights area. The grant for fellowship from the SPRIHA Scheme is admissible only in case UGC-CSIR/NET -JRF grant is not claimed.

Duration of the position: The Junior Research Fellowship or Ph.D. Fellowship Scheme is initially up to 31 March 2023 with a further provision of extension for a total period of five years leading to Senior Research Fellow from 3rd year onwards with enhanced stipend as per UGC/DPIIT norms upon satisfactory performance evaluated every year. The position is temporary and is available immediately. The selected candidate may be permitted to register for Ph.D. Program as per the norms of UGC/ AICTE and as per the University rules, if they fulfill the admission criteria of the University.

Nature of duties: The selected candidates would be undertaking research across the IP value chain, IP Policy Analysis, implementing the IPR Chair activities including teaching the IPR Course to UG/PG Students and preparation of different research, consultancy and other reports to be submitted to the government.

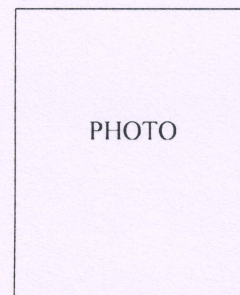
