In this connection, we would like to inform you that based on the recommendations of the Standing Committee of DEC that evaluated the application of your university, the Distance Education Council has accorded Ex-Post-Facto approval to your university for programmes offered through distance mode with effect from 1995 to ecademic year 2007-08 as per the enclosed list in Annexure-I. Prior to March 1995, there was no system for giving recognition to correspondence courses or distance education programmes and therefore the issue of Ex-Post-Facto approval for such courses during that period does not arise. Dear Sir/Madam,

This has reference to your application requesting the Distance Education Council for recognition of your programmes offered through distance mode from the year 2008-09 onwards.

In this connection we would like to inform you that your proposal for granting regular recognition to your University is under process. Meanwhile, your University has been granted continuation of provisional recognition till such time the Committee visits your University and submits its recommendations and a decision is taken by the Joint Committee on the same.

However, we maintain that it is the responsibility of the Institution/University to follow the norms prescribed by the concerned regulatory bodies and seek their recognition for professional / technical programme/s as per the requirements. Getting approval of concerned statutory apex body for relevant programme/s will be the sole responsibility of the Institution.

The DEC does not allow franchising of study centers.

Further, we would also like to mention that the territorial jurisdiction for offering distance education programmes would be as per Acts and Statutes of your University and in accordance with the UGC guidelines. Your institutions shall also follow all norms/guidelines issued by the DEC for offering programmes through distance mode a copy of which is enclosed.

#### **DEC Guidelines:**

- 1. The Institution will offer only such programmes through distance mode which are offered by the Institution through regular face-to-face mode:
- 2. The nomenclature of the programmes should be strictly as prescribed by the UGC/AICTE and approved by the Joint Committee of UGC-AICTE-DEC.
- 3. The eligibility conditions and duration of programmes will be as per the DEC norms and for professional and technical programmes as per the norms laid down by the AICTE. No admission to MBA, PGDBM and MCA programmes can be done without ensuring that that the student has secured a valid score in the entrance test examination for this purpose.
- 4. The Institution shall limit admission to maximum 60 seats per programme per Study Centre for Management, Computer & IT, and Allied Health Sciences programmes. For laboratory/Practical work, the institution can have a maximum of 30 students in a batch subject to maximum 60 students per Study Centre. The Study Centre be owned by the University and should be opened with the approval of EC/BOM of the University concerned.
- 5. The Institution should have at least one full time faculty member exclusively for coordinating each programme.
- 6. Regarding territorial jurisdiction for offering programmes through distance mode the latest UGC notifications will prevail over all previous notifications and circulars. As per the UGC notification, State Universities (both private as well as Govt funded) can offer programmes only within the State and Deemed Universities from the Headquarters and in no case outside the state. However, Deemed Universities may seek the permission to open off campus centers in other states and offer distance education programmes through the approved off campuses only after approval of UGC and DEC. Central Universities will also adhere to the UGC norms. The territorial jurisdiction for the institutions (both private as well as Govt funded) shall be the Headquarters, and in no case outside the State. Thus, the territorial jurisdiction of your Institution shall be governed by these UGC guidelines.
- 7. The Distance Education Council prohibits franchising of Study Centres. Thus, your Institution will not franchise any Study Centre.
- 8. The Institution's management of the distance education programmes will be open for review and inspection from time to time by DEC to provide inputs for further improvement or as deemed necessary. The academic norms of the programmes shall be under monitoring and regulation by the concerned regulatory authorities.

\*The programmes are professional in nature, they require approval from the concerned Statutory Councils. Technical, Engineering programmes require AICTE recognition. Any other professional degree requires approval from the concerned Statutory Councils. Hence, the approval accorded by the DEC is conditional subject to the approval of the AICTE and any other Statutory Councils. It will be the responsibility of your Institution to seek prior approval from the concerned statutory Councils/regulatory bodies, wherever required.

A. The recognition to above programme is subject to the compliance of the following by the Institution.

(i) The University should appoint in addition to existing faculty at least one faculty per programme to support the distance education programme particularly for the Science and Technology programmes as per DEC norms.

(ii) Some of the printed materials particularly Science and Law programmes need revision and updation and inclusion of some more papers as per the specialization. Curriculum for various programme particularly of professional programmes i.e law should be need based.

(iii) The University should follow the self learning methodology in updating, preparation of the new course ware and should improve its existing course ware by involving more experts on their advisory committees representing industries and academicians for preparing syllabus and developing, updating and revising the course materials as per ODL pedagogy.

(iv) As far as nomenclature of various programmes on offer and territorial jurisdiction is concerned, the University should follow the UGC guidelines.

The duration of various programmes particularly professional programmes i.e
 MBA, MCA, LLM etc should be as per DEC and AICTE norms.

(vi) In case of offer of LLM programme through distance mode, it is essential to specify the area(s) of specialization offered in the prospectus as well as in the degree awarded. Further, the course materials need to be completely revised by adding more and more latest case laws preferably belong the admission process begins for the next session.

(vii) The University should provide extensive training to the faculty, coordinators and academic counselors with the help of STRIDE, IGNOU to improve the existing study material.

(viii) The University should make use of ICT in the context of distance education system for the effective delivery of programmes. Audio/visual and multimedia material need to be developed. University should use EDUSAT also for which the University can approach those institutions which are already making use of EDU SAT or IGNOU.

## B. The University/Institution may note that:

1. The Institution will offer only such programmes through distance mode which are offered by the Institution through regular face-to-face mode and approved by the Distance Education Council as mentioned in this letter. The Institution will not offer any other programme though distance mode other than those approved by the Distance Education Council.

2. Technical, Engineering programmes require AICTE recognition. Any other professional programme requires approval from the concerned Statutory

3. Programmes in the areas of Health, Nursing, Dentistry, and allied areas may be offered with the approval of the statutory councils/regulatory bodies, wherever required.

4. It will be the responsibility of the Institution to follow the norms prescribed by

the regulatory bodies, and seek their approval, wherever required.

5. The nomenclature of the programmes should be strictly as prescribed by the

UGC/AICTE and approved by the Distance Education Council.

6. The eligibility conditions and duration of programmes will be as per the DEC norms and for professional and technical programmes as per the norms laid down by the AICTE. No admission to MBA, PGDBM and MCA programmes can be done without ensuring that that the student has secured a valid score in the entrance test examination for this purpose.

7. The Institution shall limit admission to maximum 60 seats per programme per Study Centre for Management, Computer & IT, and Allied Health Sciences programmes. For laboratory/Practical work, the institution can have a maximum of 30 students in a batch subject to maximum 60 students per Study Centre. The Study Centre be owned by the University and should be opened

with the approval of EC/BOM of the University concerned.

8. The Institution should have at least one full time faculty member exclusively

for coordinating each programme.

9. The territorial jurisdiction for offering programmes through distance mode will be as per the decision taken in the 35th Meeting of the Distance Education Council. In its 35th meeting the Council noted that distance education and online education cannot have the Territorial Jurisdiction. In case of Central Universities and the State Universities, the Territorial Jurisdiction will be as per their Acts and Statutes for offering programmes through distance mode. The Territorial Jurisdiction in case of Deemed Universities will be as per UGC, which mandates the prior approval of the UGC for opening Centres / off Campus Centres outside the Headquarters. The Territorial Jurisdiction in case of Private Institutions (other than Universities) will be as decided by the Joint Committee, which has decided that the territorial jurisdiction for the institutions (both private as well as Govt funded) shall be the Headquarters, and in no case outside the State.

10. The Distance Education Council prohibits franchising of Study Centres. Thus, your Institution will not franchise any Study Centre.

11. The Institution's management of the distance education programmes will be open for review and inspection from time to time by DEC to provide inputs for further improvement or as deemed necessary. The academic norms of the programmes shall be under monitoring and regulation by the concerned regulatory authorities.

12. For Management and Computer Science programmes, the Institution should

also note that

The programme should have a mandatory internship of six months;

 Institute/University concerned should seek accreditation from National Board of Accreditation as per prevailing rules;

 Institute/University concerned should have concerned Department and the conventional universities should have on campus programme on offer;

Institute/University concerned should not have advertised for the

programmes before receiving the approval letter;

 Institute/University concerned should disclose, on line, in public domain the details of the student admitted, centre-wise, as per the format to be prescribed by AICTE;

Institute/University concerned should ensure delivery of the course material

on-line with in one year of the date of approval;

It may be noted that before launching the programme the Institution should submit an affidavit within 30 days from date of issue of this letter that it agrees to and will abide by all terms and conditions contained in this letter. In case, the DEC does not receive the affidavit within 30 days from date of issue of this letter, the approval accorded to your Institution will be considered as withdrawn. Further, if it is found that the Institution is flouting any norms, then the recognition accorded to your Institution will be withdrawn without any notice.

Reference is invited to Office Letter No. F. No. UGC/DEB/AU/VIZ/AP/Recog./2013/4322-26 dated 22.01.2014 along with DEC/Recog/2010/2291 dated 04.08.2010 conveying the approval of the University Grants Commission (UGC) to your University for offering programmes in Open & Distance Learning (ODL) mode. In this regard, I am directed to inform that the UGC has taken decision to maintain status quo for 2014-15 and accordingly the recognition/approval granted to you vide the aforementioned letter would continue for academic year 2014-15. Your University may offer the programmes in ODL mode which were offered during 2013-14 in accordance with approval conveyed by UGC (copy enclosed).

- 2. The above recognition is subject to the following terms and conditions:
  - The University shall offer only those programmes through distance mode which are approved by the statutory bodies of the University as per norms and wherever necessary by the Apex regulatory bodies of the country.
  - ii) It is the responsibility of the University to follow the norms prescribed by the concerned regulatory body/ies such as UGC/AICTE/any other, and also seek its/their prior approval, wherever required, for any specific programme mentioned above.
  - iii) Nomenclature of all programmes shall be as per UGC/AICTE.
  - iv) No teacher education programmes can be offered without prior approval of the NCTE.
  - v) Programmes in physiotherapy are not allowed through distance mode.
  - vi) University shall refrain from offering such programmes that are not allowed to be offered through distance mode by respective apex body/ies.
  - vii) MHRD directions prohibiting B.E. / B. Tech. through Distance mode vide its letter dated 29/07/2009 shall be adhered to strictly (copy at UGC website).
  - viii) The eligibility conditions for admissions will be as per UGC/AICTE norms.
  - ix) The minimum duration of a programme offered in ODL mode should not be less than the minimum duration of similar programme offered through the regular mode.
  - x) The University has at least one full time faculty member exclusively for coordinating each programme at the headquarters.

- The territorial jurisdiction in respect of Universities for offering programmes through distance mode will be as per the policy of UGC on territorial jurisdiction and opening of off campuses/centres/study centres as mentioned in the UGC Notification No. F. 27-1/2012 (CPP-II), dated 27<sup>th</sup> June 2013, a copy of which is also posted in the UGC website www.ugc.ac.in/deb. In respect of standalone Institutions (other than the Universities), the territorial jurisdiction will be headquarters.
- xii) Franchising arrangement for offering programmes in distance mode in any form is not allowed.
- 3. The Institution's management of the distance education programmes will be open for review and inspection by the UGC. The academic norms of the programmes shall be under monitoring by the concerned regulatory authorities.
- 4. Before launching the programme/s, the Institution shall submit an affidavit within 30 days from date of issue of this letter that it agrees to and will abide by all terms and conditions contained in letter referred to in para 1 above and the terms and conditions laid down in para 2 above. In case the UGC does not receive the affidavit within 30 days from the date of issue of this letter, the approval accorded to your Institution will be liable to be withdrawn. It may also be noted that:
  - If the institution fails to comply with the conditions of recognition or if it is found conducting affairs in a manner that leads to deterioration of academic standards, the UGC may withdraw its recognition.
  - ii) In case any information, documentary evidence submitted/produced by the University is found to be false or fake at a later stage, the recognition of University shall be withdrawn and the University concerned shall be solely responsible for the career of the students enrolled.
- 5. Your university is required to send along with the affidavit, a list of programmes (approved by the statutory bodies) that are on offer through distance mode currently, duly authenticated by the Registrar.

Reference is invited to your letter no. SDE/DEB Recognition/2015 dated 15.10.2015 vide which a letter of intent and a fresh affidavit duly sworn in has been forwarded to this office. UGC vide its letter no. UGC/DEB/AU/VIZ/AP/Recog./2014/7407-7411 dated 04th June, 2014 had conveyed its approval to your University for offering programmes under distance learning mode during the session 2014-15. In this regard, I am directed to inform that the UGC vide its 505th meeting vide item no. 2.03 held on 22th December 2014 decided to maintain the status quo about recognition of the programmes, under distance education mode, during the academic session for 2015-16. Accordingly, the recognition accorded to your University, vide the above said letter of UGC, is hereby continued for the academic year 2015-16. Your University may therefore continue to offer the programmes in ODL mode, approval for which was accorded vide DEC letter no. DEC/Recog/2010/2296 dated 04.08.2010 (copy enclosed).

The university shall scrupulously abide by the following terms and conditions, while Jance with the Jane With the Jane With the Jane With the Jane With Jane 1995 and Jane offering the programmes through distance learning mode during the session 2015-16 in accordance with the Affidavit dated 15.10.2015, duly notarised and signed by Prof. Velagapudi Uma Maheswara Rao, Registrar of the University, submitted to the commission vide letter

- The University shall not start any new programme without prior approval of UGC and iii) other concerned regulatory authorities in anticipation of recognition.

- iv) The nomenclature of all the programmes to be offered under distance mode shall be strictly as per UGC/AICTE Regulations.
- v) No teacher education programme shall be offered without prior approval of the NCTE.
- vi) The Ministry of HRD's directions prohibiting B.E/B.Tech through distance mode vide it's letter dated 29.07.2009 shall be adhered to strictly.

- xi) The University shall run its ODL programmes only in those subjects/ fields which are offered by it through regular mode.
- xii) The university shall have at least one full time faculty member exclusively for coordinating each programme at the headquarters
- xiii) The eligibility conditions for admissions to each course to be offered through distance learning mode shall be as per norms of UGC/AICTE and other regulatory bodies.
- xiv) The territorial jurisdiction in respect of University for offering programmes through distance mode will be as per the policy of UGC on territorial jurisdiction and opening of off campuses/centres/study centres as mentioned in the UGC notification No.F.27-1/2012(CPP-II), dated 27<sup>th</sup> June 2013, a copy of which is also posted on the UGC website www.ugc.ac.in/deb.
- XV) The programmes in distance mode will not be offered through franchising arrangement and /or through any private institution /college
- **3.** Moreover, the University shall not offer any M.Phil/Ph.D Programme through distance learning mode in compliance to clause 5 of the UGC (Minimum Standard and Procedure for awards of M.Phil./Ph.D Degree), Regulation 2009.
- **4.** The Institution's management of the distance education programmes will be open for review and inspection by the UGC. The academic norms of the programmes shall be under monitoring by the concerned regulatory authorities.

Sub:- Formulation and notification of regulations for professional programmes to be conducted by the higher educational institutions in Open and Distance Learning mode.

Dear Sir.

Kindly refer your letter dated 13.08.2018 on the above noted subject.

We would like to inform you that Executive Committee/Council in its meeting held on 14.08.2018 considered the Draft- AICTE (Open and Distance Learning Regulation for Standalone Institutions) Regulation, 2018 framed by the duly constituted committee under the Chairmanship of Prof. Sanjay Govind Dhande, Former Director, HT, Kanpur.

The Council deliberated on various provisions of the Regulations, as applicable to the Standalone Institutions and also referred UGC(ODL) Regulations, 2017 from the perspective of maintaining sanctity of admissions, examinations, learning materials, learning support centres, territorial jurisdiction and effective use of ICT and took the following decisions:

1. Keeping in view the provisions of the AICTE Act, which mandates approval of AICTE for affiliated colleges and Deemed-to-be-universities, through the judgement of Hon'ble Supreme Court in CA No. 17869-17870/2017 & also CA No. 17902-17905/2017, dated November 3,2017, the Central Legislated Universities and State Legislated Universities including Open Universities are exempted from seeking approval from AICTE to run programmes in MBA, MCA, Diploma/Degree in Travel and Tourism in ODL mode. However, Universities shall have to adhere to minimum norms and standards announced by AICTE from time to time and an affidavit stating that the university is observing norms & standards of AICTE, must be submitted to the UGC. For all such Universities, the AICTE approval shall be considered as deemed to have been accorded for running ODL programmes in the

MBA, MCA, Travel and Tourism disciplines. However, in case of violation of AICTE norms, AICTE shall communicate its observations and recommendations to the University Grants Commission (UGC) to initiate actions including withdrawal of Programme recognition and take further actions as per provisions of UGC (ODL) Regulations 2017 and amended from time to time.

- 2. All the Deemed-to-be-Universities notified by UGC as Category-I institutions as per UGC (Categorization of universities (only) for grant of graded Autonomy) Regulations, 2018 shall be exempted from seeking approval from AICTE for the programmes mentioned in Sl. No. 1 above i.e. MBA, MCA, Diploma/Degree in Travel and Tourism. However, such Deemed-to-be-Universities shall have to adhere to norms & standards announced by AICTE from time to time and an affidavit stating that the deemed-to-be-university is observing norms & standards of AICTE, must be submitted to the UGC. For all such UGC notified Category-I Deemed-to-be-Universities, the AICTE approval shall be considered as deemed to have been accorded for running ODL programmes in MBA, MCA, Diploma/Degree in Travel and Tourism. However, in case of violation of AICTE norms, AICTE shall conduct inspection and submit its observations and recommendations to the University Grants Commission (UGC) to initiate actions including withdrawal of Programme recognition and take further actions as per provisions of UGC (ODL) Regulations.
- 3. For all other Deemed-to-be-Universities interested in running ODL programs in MBA, MCA and Travel & Tourism, AICTE shall invite applications and such Deemed-to-be-Universities shall submit applications online on the AICTE web portal within notified deadline and shall be processed as per laid down procedure, duly notified by AICTE. AICTE will forward the recommendations to UGC for further necessary action in the matter.

In view of the above, the comments of UGC, if any, may be provided urgently.
