4. DUPLICATE MARKS LISTS AND PROVISIONAL CERTIFICATE WILL NOT BE ISSUED WITHIN 30 (THIRTY) DAYS FROM THE DATE OF THE PUBLICATION OF THE RESULTS.

5. THE REQUISITION FORM FROM THE CANDIDATES FOR RE-VALUATION OF THEIR SCRIPTS SHALL BE ADDRESSED TO DEPUTY REGISTRAR (EXAMS), SCHOOL OF DISTANCE EDUCATION, ANDHRA UNIVERSITY, VISAKHAPATNAM AND REACH HIM WITHIN A PERIOD OF 30 (THIRY) DAYS FROM THE DATE OF DESPATCH OF MARKS AFTER PUBLICATION OF THE RESULTS AT THE OFFICE OF THE SCHOOL OF DISTANCE EDUCATION.

THE CANDIDATES DESIRING REVALUATION OF THEIR VALUED ANSWER SCRIPTS ARE REQUIRED TO PUT IN THEIR REQUISITIONS ACCOMPANIED BY (I) A DEMAND DRAFT IN FAVOUR OF THE REGISTRAR ANDHRA UNIVERSITY, VISAKHPATNAM TOWARDS THE PRESCRIBED REVALUATION FEE RS.750/- (RUPEES SEVEN HUNDRED AND FIFTY ONLY) FOR EACH ANSWER SCRIPT AND (II) A SPECIMEN HANDWRITING
